ORDER

29 APR 2015

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 37 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in pursuance of the National Council for Teacher Education (Recognition Norms and Procedural Regulations, 2009, the National Council for Teacher Education has notified its Regulations, 2014 on 9.12.2014.

2. **AND WHEREAS**, the institution **Tribeni Teacher's Training College, Gandhi Chowk, Mansapur, District - Jaipur, Rajasthan** has by affidavit consented to come under New Regulations and sought for two beds under 3(B), which require additional facilities.

3. **AND WHEREAS**, it has been decided at parna the institution has basic norms of 10 students each subject to fulfillment of the following conditions namely:

- (i) The institution shall create additional facilities which include (a) additional hall-rooms, (b) additional classrooms, (c) additional faculty, (d) additional staff rooms as per Regulations, 2014 and inform the Regional Commission with required documents by October 31, 2015.
- (ii) The applicant institution, for admission into all be required to submit the required documents, such as land documents, Non-Encumbrance Certificate (NOC), Land Use Certificate (L.U) and the Building Plan (BP) to the extent available on the website, to the Regional Commission in proof of having provided additional facilities, before October 31, 2015. Building Completion Certificate (BCC) may be pending along with other documents, if available, otherwise it may be given in the 'Waiting Books' at the time of inspection.
- (iii) The Regional Commission shall arrange for verification of documents, inspection of the premises and check adherence to these conditions by 20 February, 2016. If it is found by the Regional Commission that the institution fails to comply with these requirements, the institution shall not be permitted to admit students for the academic year 2016-2017.
- (iv) In case any existing institution's number is available under cover directions/N order section 17 of the NCTE Act/Commission, the institution shall be required to submit a copy of the State/Central/State/University or UGC completion/initially submitted alongwith the documents, if any regarding the documents referred above. In case the institution's consent for doubling of premises is pending, such institution shall be required to submit the required documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as referred in the subject. Final decision shall be subject to the direction given by the State/Central Govt. in the 'Waiting Books' decided by the Northern Regional Commission in respect of Section 13 compliance cases etc.

4. **Now therefore**, in the light of the above, the Northern Regional Commission, NCTE hereby issues the revised Recognition Order to **Tribeni Teacher's Training College, Gandhi Chowk, Mansapur, District - Jaipur, Rajasthan** for conducting B.Ed. programs of two years duration with an enrolment of 100 for two beds with of 20 students each from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein, Section 31.3.2015.

5. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, Affiliating University/Body, State Government etc. as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of

the list & holding documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.


6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accountability submitted by a Chartered Accountant.

7. The institution shall maintain & update its website as per provisions of NCTE Regulations and always display following as mandatory disclosure:

- (a) Sanctioned programmes along with award levels in the institution.
- (b) Name of the library and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photographs.
- (c) Name of faculty members who left or joined during the last quarter.
- (d) Names of students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- (e) Fee charged from students.
- (f) Available infrastructural facilities.
- (g) Facilities added during the last quarter.
- (h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- (i) The affidavits with enclosures submitted along with application.
- (j) The institution shall be free to omit additional relevant information, if it so desires.
- (k) Any false or incomplete information received by the institution leads to the withdrawal of recognition.

If the institution Contravenes any the above conditions or the provision of the NCTE Act, Rules, Regulations and Order made and issued there under, the institution will render itself liable to disciplinary action including withdrawal of recognition by the Regional Committee under the provision of Section 17(i) of the NCTE Act.
